### Meet the Network

#### **Aaradhna Gupta, CUTS International (India), 26**

Aaradhna works directly with consumers to solve their grievances as part of the Consumer Care Centre at CUTS International. Aaradhna is also involved in financial consumer protection activities and is particularly interested in the need for education on consumer rights in India. Aaradhna has a law degree from Nirma University, Ahmedabad and practiced as a lawyer prior to joining CUTS International.
